Resolution # 5 of 2024

WHEREAS, the County of Ulster (the "County") is authorized to levy and collect taxes upon parcels of real property located within the County; and

WHEREAS, the Village of Saugerties (the "Village") is located within the County and is authorized to levy and collect taxes on parcels of real property located within the Village; and

WHEREAS, the County and the Village are each designated as a "tax district" in NYS Real Property Tax Law §1102(6); and

WHEREAS, NYS Real Property Tax Law §1150 authorizes tax districts to make agreements with one another with respect to any parcel of real property upon which they respectively own tax liens in regard to the disposition of such liens and the avails thereof; and

WHEREAS, the County has commenced a proceeding in the NYS County Court for the County of Ulster, pursuant to Real Property Tax Law Article 11, to foreclose the lien of real property taxes which remain delinquent after the expiration of two years following the lien date as prescribed in Real Property Tax Law §1110; and

WHEREAS, certain of the parcels of real property described in the County's foreclosure Petition are situated within the Village, upon which tax sale certificates were issued to the Village for reason of the delinquency in payment of Village real property taxes and which remain unredeemed; and

WHEREAS, the County has presented the Village with a proposed AGREEMENT RELATING TO ENFORCEMENT OF REAL PROPERTY TAX LIENS, a copy of which is annexed hereto (the "Agreement"); and

WHEREAS, the Agreement provides, in sum or substance, that the Village shall be paid from the proceeds of the sale of those parcels identified in the Agreement's Schedule, in an amount equal to the unpaid real property taxes, together with any additional interest accruing thereon from and after May 1, 2024, and if the funds received upon such sale are insufficient to pay all amounts owed to both the Village and the County (including interest) any funds received shall be shared by

the County and the Village pro rata; and

WHEREAS, the Village attorney has reviewed the Agreement, deemed it compliant with the Real Property Tax Law, and adjudged that the Agreement is sufficiently clear and unambiguous as drafted.

NOW, THEREFORE, THE BOARD OF TRUSTEES RESOLVES AS FOLLOWS:

- 1. The terms of the Agreement are fair and reasonable, and in the best interests of the Village and its residents.
 - 2. The Board of Trustees hereby determines to accept the terms of the Agreement.
- 3. The Mayor is hereby authorized and directed to execute the Agreement on behalf of the Village, and deliver the executed Agreement to the County.
