REGULAR MEETING

If Ben would be comfortable doing this. The Board is required to have 2 hours of education. Eyal stated that there is nothing new i.e.: Zoning Law. The education would be refresher.

Received a request from Andrew Zink about Zoning, will be meeting with him tomorrow to discuss it. In the R3 building is ok, rezoning to an R2 would not be ok. Discussed the topic with the Mayor, Zoning Laws made in 1985, 40 years. The Planner should be hired to look at the whole Zoning in the Village. The goal The Zoning Board deals with minor changes currently. A good Zoning Law measures how busy your Zoning Board is, if they are inundated with requests the Zoning isn't working. Eyal would like input from Planning Board, Zoning Board and review the history.

Dara Ellenbogen made a motion to adjourn the Planning Board meeting. The motion to adjourn the Planning Board was seconded by Sean Paige. All in Favor. The motion carried unanimously. The meeting adjourned at 6:57pm.
